- Identify strategic opportunities to collaborate with other jurisdictions and key stakeholders.
- Lead the development of, and provide, strategic intergovernmental and international relations policy advice to OPS ministries, including advice related to intergovernmental and international agreements, negotiations, protocols and communications.
- Maintain a wide network of contacts and relationships (internal/external to the OPS) to ensure strategic awareness of federal, provincial and territorial, and international activities.

• You have strategic senior leadership experience and have led organizational transformation and can translate organizational priorities/direction to stakeholders and staff.

- You have knowledge of the structure, operations, policy-framework and decision-making processes of the Government of Ontario.
- You have knowledge of federalism and the constitutional division of powers, and the implications of these for intergovernmental relations and policy development in Canada.
- You have demonstrated success in developing and leading horizontal policy initiatives in interministry and intergovernmental environments.
- You have strong political acuity, commitment to innovation and creativity.
- You have demonstrated research, policy analysis, and intelligence gathering skills.
