Inflation and Models: Distilling Dynamics for Monetary Policy Decision-making

Abstract: The series of shocks and subsequent evolution of the macro-economy present challenges to forecasting inflation. Some models have been estimated over time periods without major shocks or surges in inflation. Some models are linear and symmetric. Some models skimp on the micro-foundations of price-setting or wage-setting behaviours. Some models incorporate a static financial market. Central-bank researchers have risen to these challenges, and have produced research addressing these aspects, which are directly relevant to understanding the dynamics of inflation today. Key for monetary policy decision-making is how to distil from both existing models and new research a cohesive picture for how inflation might evolve under different economic and monetary policy scenarios.

Catherine L. Mann

External Member Monetary Policy Committee, Bank of England



Dr Catherine L Mann was appointed to the Monetary Policy Committee of the Bank of England on 1 September 2021 for a three-year term.

Dr. Mann is a Professor of the Practice at Brandeis University. She contributes to the research program of The Productivity Institute and is a Science Advisor to the European Investment Bank. She is a member of the Council on Foreign Relations and the American Economic Association, among others. Previously she was Chair of the Economic Advisory Committee of the American

Bankers Association, a member of the Executive Board of the Committee on the Status of Women in the Economics Profession, on the Board of the National Association for Business Economics, and of the advisory committees of the Federal Reserve Banks of Chicago, Boston, and New York.

Prior to her appointment, she was the Global Chief Economist at Citibank (2018 to 2021) and the Chief Economist, Head of Economics Department, and G20 Finance Deputy at the OECD (2014 to 2017). Previous to these, she was Rosenberg Professor of Global Finance at Brandeis University, Senior Fellow at the Peterson Institute for International Economics, and Assistant Director in the International Finance Division at the Federal Reserve Board.

Dr. Mann's research has focussed on international economic relationships and outcomes, including trade, finance, climate, productivity, and inequality. She has authored or co-authored seven books, 60-plus articles, and numerous shorter pieces and testimony.

Mann's university degree is from Harvard, and her PhD is from the Massachusetts Institute of Technology.

Douglas Porter has over 30 years of experience analyzing global economies and financial markets. As Chief Economist at BMO Financial Group and author of the popular Talking Points, he oversees the macroeconomic and financial market forecasts and co-writes the firm's weekly flagship publication, Focus. Mr. Porter manages the team that has won numerous forecasting awards. Most recently, Douglas led the team to a #1 ranking for Top U.S. Forecaster among 60 global firms in the 2023 Focus Economics Survey, and #1 for Top Canadian Inflation Forecaster among 28 firms. Also, his

team took the #1 spot in the StarMine Awards for Most Accurate Forecasters for Canada in 2022.

As a respected commentator on economic and financial trends, he is regularly quoted in the national press and often interviewed on radio and television.

Douglas' career began at the Bank of Canada; then, before joining BMO, he held the positions of Economist and Country Risk Analyst with other Canadian financial institutions.

He has been a member of C.D. Howe's Monetary Policy Council since 2008 and serves on the Investment Management Committees of the Bank of Montreal's Canada Pension Plan and Western's Endowment Fund.

Peterson joins The Conference Board from Citi, where for many years she served as a North America Economist and later as a Global Economist. Her wealth of experience extends to the public sector, having also worked at the Federal Reserve Board in Washington, D.C.

Dana's wide-ranging economics portfolio includes analyzing global economic themes having direct financial market implications, including monetary policy; fiscal and trade policy; debt; taxation; ESG;

Chris is an executive in residence at the University of Victoria's Gustavson School of Business. Inbal is a multidisciplinary economist who leverages the power of research, innovation, and collaboration to create positive impact. With experience in the private and nonprofit sectors, Inbal joined the Canadian public service 10 years ago as the first economist to establish the economic research portfolio to research and demonstrate the economic, social and environmental impact of standardization at the Standards Council of Canada (SCC). Over the recent years, she developed the strategic foresight capacity at SCC, which resulted in key Canadian leadership positions and input into

international standardization bodies (ISO and IEC). While serving as Special Advisor to the CEO, she advanced connecting foresight and research to current strategic needs.

Currently, Inbal is a defence scientist at Defence Research and Development Canada where she researches and leads work on S&T foresight, risk assessment, innovation economics, and ethics of emerging technologies and data in safety and security. She has been working on advancing diversity, equity and inclusion across the economics discipline through her governance work as a National Director at the Canadian Association of Business Economics, a Co-chair Best Practices Committee of the Canadian Economics Diversity Committee, Canadian Economics Association. Furthermore, as a social entrepreneur she is building a grassroots children and youth leadership programs for immigrants to increase their sense of belonging and long-term integration in Canada. Finally, she is also developing a financial literacy platform to help individuals and families create financial habits that last.

Stabilization Policy in a Period of Structural Change

David Dodge

Senior Partner Bennett Jones LLP and Former Governor of the Bank of Canada



Mr. Dodge is Senior Advisor at Bennett Jones LLP one of Canada's leading law firms. He also serves on the board of the Canadian Institute for Advanced Research, and Chairs the National Council of the C.D. Howe Institute.

During a distinguished career in the federal public service, Mr. Dodge held senior positions in the Central Mortgage and Housing Corporation, the Anti-Inflation Board, and the Department

of Employment and Immigration. After serving in a number of increasingly senior positions at the Department of Finance, including that of G-7 Deputy, he was Deputy Minister of Finance from 1992 to 1997. In that role, he served as a member of the Bank of Canada's Board of Directors.

In 1998 he was appointed Deputy Minister of Health, a position he held until his appointment as Governor of the Bank of Canada.

Mr. Dodge, appointed Governor of the Bank of Canada, effective 1 February 2001 for a term of seven years, retired on 31 January 2008. From July 2008 to June 2014, he served as Chancellor of Queen's University. From 2009 to 2015, he was a member of the board of directors of Canadian Utilities Limited, ATCO Limited and the Bank of Nova Scotia.

A native of Toronto, Mr. Dodge received a bachelor's degree (honours) from Queen's University, and a PhD in economics from Princeton.

During his academic career, he taught economics at Queen's University; at the School of Advanced International Studies, Johns Hopkins University; at the Faculty of Commerce at the University of British Columbia; and at Simon Fraser University. He also served as Director of the International Economics Program of the Institute for Research on Public Policy. Mr. Dodge has been awarded honorary degrees from a number of Canadian universities. In 2009, he was elected a fellow of the Royal Society of Canada.

Brett House (moderator)

Professor of Professional Practice in Economics, Columbia Business School

Brett House is Professor of Professional Practice in Economics at Columbia Business School in New York, as well as a Fellow with Canada's Public Policy Forum and a Senior Fellow at the Munk School and Massey College at the University of Toronto. Previously, Brett was Vice-President and Deputy Chief Economist at Scotiabank; a member of the founding team and Chief Economist at Alignvest Investment Management in Toronto; and Global Strategist at Woodbine Capital Advisors in New York.

Earlier in his career, Brett served as Principal Advisor to the United Nations Secretary-General and as an Economist at the International Monetary Fund. He cut his teeth in fixed-income markets at Goldman Sachs in London and at the World Bank in Washington, DC. Brett is a Rhodes Scholar with degrees in economics from the University of Oxford and Queen's. He taught at Oxford and McGill.

Jatin Natwani, Professor and Ontario Research Chair in Public Policy for Sustainable Energy is the founding Executive Director of the Waterloo Institute for Sustainable Energy (WISE) at University of Waterloo. He is cross appointed to the Faculty of Engineering and the Faculty of Environment. In the Faculty of Engineering, he is cross appointed to the Department of Management Sciences and the Department of Civil and Environmental Engineering. Professor Nathwani joined the University of Waterloo in 2007.

Professor Nathwani is currently leading a 'Global Change Initiative - Affordable Energy for Humanity' to address the challenge of enabling universal access. The focus of this global collaborative effort involves leading universities around the world. The twin goals are to drive the scientific and technological innovations required for energy transitions to a cleaner 'low carbon' energy system and to deliver affordable energy to the vast proportion of humanity that has minimal access to electricity and modern fuels for basic needs.

Professor Nathwani's research interests include energy policy developments, entrepreneurial business innovations for sustainable energy solutions, life-cycle risk management of energy systems, decision-frameworks for managing life safety risks and assessment of strategies and policy instruments for achieving environmental objectives.
